






### Publications (1A-1G, 2)








Membership numbers decreased due to the cancelled annual conference, when many people plan their renewals.



## Leadership Academy (1A-1G, 2)

2020-2021 saw the third cohort of participants in the WSCA Leadership Development Program. This year-long program explored leadership from the school counselor position and provided participants the opportunity to deepen their understanding of individual leadership strengths and leadership philosophy. Participants had cohort training in addition to observing and participating in WSCA leadership meetings, WSCA Summer Academy and WSCA NSCW Breakfast virtually. Program participants were expected to be better equipped to lead their profession at the building, community, and state levels.
